CALL TO ORDER (Llame Pedir) on 4/14/18 at 4:30pm by Roy E; Alt-Chair, at the Sheraton North Hotel, 15700 JFK Blvd in the Houston Room at the SETA Assembly. There were approximately 26 folks in attendance. He opened the meeting with the Serenity Prayer.

CHAIR REPORT (Coordinador Informe) - Roy E for Chris D

Chris reported the SETA CFC 2019 budget proposal was submitted. The 2019 budget totals were based on 2017 actual numbers. He noted 3 key points: (1) 2017 totals were misleading because some of the monies related to the 2018 SETA CFC Conference. (2) Due to this methodology he requested an increase of \$500 to cover costs anticipated to fund the National Conference in 2019. (3) All need to turn in printing receipts so we can get a better idea of actual printing cost. It appears most members are printing from home or office printers and not turning in receipts to be reimburse.

Alt-CHAIR REPORT (Coordinador Informe) - Roy E;

SETA CFC held our annual spring TDCJ Special Volunteer Training at Houston Intergroup on 3/24/18. We had 61 people in attendance. It was good to see that most of them were AA members because we didn't post it on the TDCJ website. We attempted to have a workshop at the end of Orientation yet not many stayed. A few folks came just for the workshop and were given information. It appears some of them will be participating in the new meeting we have at the Cleveland Correctional Unit on Friday's at 1pm.

We are hosting 3rd Annual National Corrections Conference November 1-3, 2019. SETA CFC has a separate bank as per guidelines established by the Advisory Board of the Nation Corrections Conference.
