- Reviewed the purpose of the Southeast Texas Area CFC, including:
  - Supporting AA outreach in county jails, state prisons, and federal facilities.
  - Assisting with volunteer orientation and application approval.
  - Distributing AA literature funded by Blue Can contributions.
  - Responding to inmate letters through the Correspondence Program.
  - Using Bridging the Gap channels for pre-release support.
  - Providing information tables at workshops and conventions.
- County Jail Volunteer Application Concerns
  - Ten volunteers applied to take meetings into Harris County Jail.
  - Applications are reportedly not processed yet.
  - Attempts made to contact jail coordinator; no response received.
  - Group informed us of typical county delays and limitations.
- Correspondence Program Update
  - Limited number of letters currently being received.

- Some new volunteers identified to write letters.
- Request for anyone interested in providing contact information.
- Tracking of correspondents being maintained via spreadsheet.
- Additional coordination is needed with Area 68 for out-of-region letters.
- National Corrections Conference Report
  - Attendees met with previous and new corrections desk personnel.
  - Information shared regarding contact procedures for out-of-area facilities.
- Securus App Training Workshop Planned
  - Proposal to hold a half-hour workshop in January to:
    - Download the Securus app.
    - Learn how to use messaging features where allowed.
  - Spanish district participation requested.
  - More research is needed to understand facility-specific messaging rules.
