#### **Approved Minutes**

**CALL TO ORDER (Llame Pedir)** on 12/20/17 at 7:30 pm by Chris D at the Delta Club (6400 Westpark, Suite 355 Houston) with a moment of silence followed by the Serenity Prayer. All were welcomed. Approximately 18 members were in attendance.

## CHAIR REPORT (Coordinador Informe) - Chris D

- Opening Remarks: Happy to be back as he had to miss last month's meeting.
- The Master Roster was circulated for corrections and/or updates.
- He made another request for the Subcommittee Chairs to email him their updated job descriptions. If no changes are needed to job descriptions do sent Chris D an email stating "No changes".
- He informed the Committee of the Delta Club's new location: 6401 Southwest Freeway, Suite 110 Houston, TX 77074. He facilitated a discussion on the SETA CFC meeting location options. The consensus was to move the SETA CFC monthly meeting with Delta. All were in favor.

It was agreed upon that such literature request be carried in by volunteers.
- Cindy M was nominated as 2018 SETA CFC Conference Chair and Roy E as the Alternate Chair. All were in favor. Roy E was nominated as Chair for the 2019 National CFC Conference; Amy E as Alternate Chair; Tammy Z as Treasurer; Larry L as Program Director and Joel G (SETA IT Chair) volunteer to help with website set up. All were unanimously voted in by acclimation.

## <u> ALT CHAIR REPORT – Roy E</u>

- He has been working with Clint Morris, TDCJ and NETA on getting a meeting in at the Duncan Unit in Dibol Texas. This unit is real close to the SETA NETA border so both Areas are going to try to get volunteers there each month. They may get two meetings a month. Roland and Roy volunteered to go into the Duncan Unit in Dibol. He stated that most of the other TDCJ units have meetings and are in need of volunteers at those units as well.
- He discussed the Final National Corrections Conference Report. At the final meeting of the Advisory Council they ended up with an excess of \$8285.00 and the Committee voted to pass it on to Maine. Maine asked for only \$4000.00 in seed money and suggested the remaining \$4285.00 be transfer to Texas for the 3<sup>rd</sup> Annual National CFC Conference. SETA CFC will need to set up a separate bank account for the funds. As mentioned in the Chair report above the primary Committee for the 3<sup>rd</sup> Annual Corrections Conference 2019 has been set up to handle the new account. All agreed to focus much attention to this year's 2018 SETA CFC Conference then begin the planning on the 3<sup>rd</sup> Annual National Conference.
- He is currently looking for good CFC speakers, panel presenters and workshop ideas.
