- Jim/Chair Took a meeting to Ferguson, but Mike Barber Ministries was there for a live broadcast, so there was no meeting. Did get in to see the guys at Eastham Unit, and was supposed to go from there to the Trinity Group, but some folks got lost, so the presentation didn't happen.
