## a. GSO Agenda Item Discussion

#### Section VI: Literature M – Eddie M opened discussion

ITEM M: Discuss new proposed agenda items (PAl's) related to the Plain Language Big Book Translation. Background Notes: Excerpt from the October 29, 2022 trustees' Literature Committee report:

The trustee's' Literature Committee agreed to forward to the 2023 Conference Literature committee all new proposed agenda items related to the Plain Language Big Book as one grouped item. The committee also discussed requests from some members regarding access to the draft of the Plain Language Big Book. After legal consultation, the committee agreed to provide a monitored closed reading room for Conference members only during the 2023 General Service Conference, where Conference Literature Committee members will be given first viewing of draft chapters in a controlled environment.

Background: 1. List of Proposed Agenda Items (PAI) related to 2021 General Service Conference Plain Language Big Book translation

#### **Discussion from Group:**

1. The PLAIN LANGUAGE BB – changes words Bill wrote to simplify for today's audience and education levels. (11th grade to 4th grade level)

Concerns and comments discussed: "Breaking it down for those not as educated is a good thing." Christina S. "I am of the opinion; BB is already in plain language." Byron. "It might be uncomfortable to learn the words as written but it takes time and effort." Caroline. "My experience is with the original Bill written text, what if I am asked to sponsor someone with this new text?" Bahiyyah. "Does this plain language BB stay within the confines of our primary purpose which is to carry the message. Will this make it more readily available to those still suffering." Don. "Bill used specific words for specific reasons." Kristi. "I used the BB dictionary." "Relevant vernacular can help us understand." Leslie "We are biased so should have outside reviewer." Sergio.

Who is the author? Eddie: The writers of the Plain Language BB is not an alcoholic or in recovery. Outside writing firm.

2. 5<sup>th</sup> Edition – New Preface only. NO 164 page text change. Stories to be updated. Currently reviewing 2800 stories submitted.

#### Section IV: Finance F – Kristi N opened discussion

Background Notes: Excerpt from the October 29, 2022 trustees' Literature Committee report: The trustees' Literature Committee reviewed proposed agenda items related to the changes approved by the 2021 General Service Conference to the book Twelve Steps and Twelve Traditions and noted the importance and interest of the Advisory Action to the Fellowship. Twelve Steps and Twelve Traditions PAIs.

The trustees' Literature committee agreed to forward to the 2023 Conference Literature Committee all proposed agenda items related to the changes in the book Twelve Steps and Twelve Traditions as one grouped item with the suggestion that the Conference Literature Committee consider forwarding the item to the general service areas for wider discussion looking toward setting a policy on how and whether to edit A.A. founder's words in our current literature. The agenda item would be discussed by the Fellowship during the 2023-2024 Conference year and considered by the Conference Committee on Literature at the 2024 General Service Conference. 2021 General Service Conference Advisory Actions <a href="https://www.aa.org/m-39-advisoryactions.o

- 1. A revision be made to page 117 in the book, Twelve Steps and Twelve Traditions, replacing the phrase "opposite sex" with the word "partner" as follows, and that a footnote be added to provide context to the change as it relates to inclusivity: The text on page 117 which currently reads: "Nearly every sound human being, experiences at some time in life, a compelling desire to find a mate of the opposite sex with whom the fullest possible union can be made spiritual, mental, emotional, and physical. This mighty urge is the root of great human accomplishments, a creative energy that deeply influences our lives. God fashioned us that way. ..." Be revised to read: "Nearly every sound human being, experiences at some time in life, a compelling desire CONFIDENTIAL: 73rd General Service Conference Background to find a partner with whom the fullest possible union can be made spiritual, mental, emotional, and physical. This mighty urge is the root of great human accomplishments, a creative energy that deeply influences our lives. God fashioned us that way. ..."
- 2. The sentence which includes the phrase "lustful enough to rape" in paragraph one on page 66 in the chapter "Step Six" of the book, Twelve Steps and Twelve Traditions, be revised to refer to the Seven Deadly Sins without specific mention of examples that are severe in nature as follows, and that a footnote be added to provide context as to the basis for the change: The text on page 66 which currently reads: "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health." Be revised to read: "No one wants to commit the deadly sins of anger, lust or gluttony."

**Discussion from Group and consensus votes taken:** "The term Partner does not bother me." "Inclusive." "Regarding the list want it to go back to the original writings as I prefer the directions given be exact/specific." "Why change the way it was written." Rescind back to original text.

- Page 117 rephrase proposed: Opposite Sex to Partner
  - Vote to rescind the use of "Partner"
- Page 66 Step 6 Paragraph 1: List Anger, Lust, Gluttony (go back to original text)
  - Vote to rescind and go back to original verbiage Consensus YES to go back to original verbiage

Section X: Treatment and Accessibilities E – Taylor C

#### Taylor - Not present / Leta presented on his behalf Section X: Treatment and Accessibilities E

Proposed Agenda Item # 29 Section X, Item E: Consider request to do an Accessibilities Inventory of Alcoholics Anonymous throughout its services and structure.

The presentation of this item for the 73rd GSC, comes out of the October 30, 2022 meeting of the Trustees' C.P.C./Treatment and Accessibilities Committee based on the proposed agenda item from Kurt. W of Area 29 in Maryland to "Consider request to do an organization-wide 'Accessibilities Inventory' of Alcoholics Anonymous throughout its services and structure evaluate what is found to communicate and improve how we function. The committee also called for an action plan for improvements be made from the information gathered.

#### Background information from the original submittal:

What problem does this proposed item address?

While many items and services such as large print literature, audio format literature and accessibility committees and accessibility guidelines exist, an inventory would empower the very members who have and live with accessibility issues, the platform to communicate their needs.

What level of group conscience discussed the proposed agenda item?

This idea has been spoken of at the monthly All Access accessibility meeting as well as the Area 29 Accessibility Committee and received positive feedback. It was brought to the Area 29 Assembly on August 13, 2022 and approved unanimously.

What are the expected outcomes if this proposed item is approved?

This process would ideally include members with a disability or accommodation need and also professional's familiar with how to optimize and organize these services. Information obtained and suggestions for change would be shared with the fellowship.

#### Discussion from Group and consensus votes taken:

- Keep Spanish Literature
- Groups should take accessibility Inventory
- Exploring how we meet needs of all attendees at conventions, assembly, etc... (sign language?)
