

#### **CONCEPT FIVE**

"Throughout our world service structure, a traditional 'Right of Appeal' ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered."

## Trusted Servants Have a Right of Appeal

The right of appeal means that if someone is unhappy with a decision made by an authority or organization, they have the right to request a review of that decision by a higher authority or independent body. This is a way to ensure that decisions are fair and just, and that individuals have a chance to challenge decisions that may negatively affect them.

After each vote on a policy in AA, the minority opinion is allowed to speak to protect their views. If the motion gets a majority vote but fails to pass due to lack of a two-thirds vote, the majority may speak. This protects the minority from being overruled by an uninformed, misinformed, majority
