- Operating Fund as of 1/1/2019 is \$70,811.62. Deposits totaled \$33,320.45. Checks written totaled \$25,869.64. Net change of \$7,450.81 making the Balance Ending on 6/30/2019 of \$78,262.43.

- Second box is our Gratitude Dinner Fund breakdown as of 6/30/2019 is \$2,889.

2020 SETA Convention is January 24-26, 2020 at the Moody Gardens Hotel and Resort in Galveston, TX. Online registration is up and running. The website address to register and for all other information is at setaconvention.org.

Preregistration is \$12 and \$15 at the door. Room rates are \$129 per night.

All speakers are lined up excluding the Alateen and Spanish speakers, but we're confident that will take place in the next few weeks.

Total registration so far is around 60+, so please register and get the word out how important is it to preregister.

Something that I have overlooked as Chair of this convention is that the hospitality suite is not the responsibility of this convention to pay for or host. What worked well:

Including the Hispanic community with speakers and a LaVina writing workshop with 21 submissions.

#### 2019 Regional Forum Report – Melissa R.

The Regional Forum is 3 months away. The dates are October 11-13 and it will be held at the Sheraton IAH.

This event is put on by GSO and the location rotates among the (11) areas in the SW Region. Because it is a bi-annual event, we have the opportunity to host it only every 22 years.

This is a wonderful opportunity for everyone, but particularly those who've never attended a Forum because they were held in locations too far away, or for those newcomers to service.

This is your opportunity to meet the GM and other staff from GSO, as well as some of our Trustees. You'll see presentations, attend workshops and have many opportunities to ask staff and trustees any questions you may have.

It has become one of my most favorite AA events.

The rooms are \$82/night, which comes to a total of \$191.88 for the weekend. You can register for your hotel room now. Because GSO doesn't want a lot of unfilled registrations, they don't open Registration for the Forum until August. We'll let you know when you can go online to aa.org and sign up to attend.

Because we are the Host District, we don't have the obligation of paying for the hotel or ensuring that we meet room-nights – though I encourage everyone to stay at the hotel for the event, just for the experience.

As the host district, we do provide certain things, mostly in the way of service, such as manning registration, providing greeters, packing and setting up the displays, etc.

We also provide things such as coffee, hospitality suite and an ice cream social. This won't require very much from us as an area. We've estimated around \$1500 to cover coffee, ice cream and snacks for the hospitality suite. We plan to submit an agenda item at the October Assembly in which we'll request this amount.

At this time, we also need a Hospitality Suite Chair. If anyone is interested in serving in this position, please let me know.

I also want to note that Ron C. has agreed to swap positions with me, so he will be the Chair of the Host Committee while Deborah D. has agreed to be a co-alternate with me.

## Delegate Report – Troy B-D.

I completely forgot that I had to actually provide a Delegate's report to the Assembly since I was so totally focused on the General Service Conference report. So, here is my brief report.

We have two new GSO staff members, Brenda B., who comes from the Memphis Intergroup where she served for 17 years. We also have Irene D., who most of you will recall served as the La Viña Editor for the past few years. Irene has moved to the AAWS side of the floor.

Yesterday I announced the 8/06 Challenge, to encourage all our members to donate \$8.06 to GSO to help us become fully self-supporting. This figure is an estimate of the cost of services per individual member based on the number of members we believe we have and the actual cost of services from the 2018 finance report.

There was a question yesterday during my GSC report about the actual cost for the GSC per Delegate. I have tracked those figures down and can report in 2018 the total cost per area was \$8,030.61 and in 2017 the cost was \$5,665.13. A few things to think about the difference in costs is based on the location of the conference, 2018 we were in New York City and in 2017 we were in Rye. Also, while the cost is divided between 93 areas this is the cost of the entire conference which includes all 133 (or so) voting members. The voting members include Trustees, Non-Trustee Directors, Staff and any observers (if there were any).

AAWS in the midst of transitioning to a new Enterprise Resource Platform (ERP) which will integrate all the existing software platforms the office uses. This will significantly improve the functioning of the office. However, we will see a shutdown of online services which includes the online bookstore and the online contribution center between the dates of July 26<sup>th</sup> and August 5<sup>th</sup>. Please make note that once the platform is back up and running members will need to save any recurring payment information online, this includes personal credit card numbers that you had set up for monthly contributions.

I want to thank Kris for his continued service, and we have met with all our DCMs and have a schedule for reporting to the Districts over the next few months. I want to also give a shout out to Christina for helping us handle the transition across the street for this quarterly assembly. I think that this weekend could have been a train wreck, but it has been really well planned out and I do think that this hotel is well designed for our purposes.

- Disaster Response Committee report (via Peter C. sent on July 10):
  - I have received Spanish literature, copies of la Vina and the Grapevine for DRP boxes and distributed them to clubs that already have boxes. I have distributed laminated meeting guides in Spanish and English to some clubs that already had boxes and will add them to the remaining boxes and will deliver them to GSRs from clubs at the July Quarterly.
  - I talked with Julian L, Beaumont Intergroup Manager, at Texas State Convention and on June 30<sup>th</sup>. She will follow the procedures I have outlined in District 90. I will be meeting with her at the District 90 Conference in August and will talk with Della, District 90 DCM, at SETA Quarterly. I will be preparing a summary of the steps I have taken before the Quarterly. I will be sending her guidelines today because of the potential storm in the gulf but Beaumont probably will not implement them because she is out of state this week.

Hey everybody My name is Roy and I am serving as Chair Person for SETA CFC

We meet every month at Spanish District 66 office, which is located at 5645 Hillcroft #410 which is between 59 and Westpark. Except on quarterly Assembly months.

All of our positions have been filled now including IT Liaison.

So far, Our Blue Can contributions for the year are up to \$35,063.35. We do want to thank everybody for that. All this money is used only to purchase Conference approved literature to go inside of prisons and jails. Our volunteers use all this each month to have books to carry into our 30 or so meetings we do in prisons and jails. Some literature goes through the mail too. Sometimes we have a little excess and we usually buy a bunch of Grapevines at a discount rate to take in.

Always need volunteers to take meetings in to these prisons and jails, as well as need people to do correspondence and sponsor by mail.

District 81 CFC and SETA CFC had a TDCJ volunteer training at the Clear Creek Club on May 18th. And about 55 attended. A couple of those are staring to go in.

We will be having another training in late September or middle of October at the Intergroup Office Conference Center.

We had a Spanish workshop last month at District 64 and attended the service workshop in district 70 at the Clear Creek Club and did make known what CFC does.

We attended the State Convention and set up our displays and got a few people signing up for correspondence and saw a lot of interest in volunteering to take meetings in and hopefully they keep coming back.

TDCJ has appointed a new volunteer services director and she is a seasoned employee with TDCJ volunteer services and is cooperating with us very well. We went a month or 2 without a Volunteer Services Director.

There still is not an official corrections desk person yet at GSO, but Susan B is filling in and getting us our correspondence and pre-release request that happen to go through AA in New York.

Susan tells me that when they hire someone their first order of business is to attend the National Corrections Conference. Be nice if they got down here for the forum too.

There will be a corrections conference in Area 27 Louisiana on September 14th. The neat thing is that it is going to be at the Angola Prison Unit. It is a one day event so if you interested get with me. Area 27 with the help of the national corrections conference is having a CFC conference call every Sunday. This is for anyone interested in corrections and it is for the corrections chairs in all of the 93 areas. We get a lot of feedback on what the other areas are doing and of course we try and talk up the national corrections conference.

NETA Area 65 is having a corrections conference in Allen Texas on October 5 and SW Regional Trustee Jimmy D and Roland R and Ola from Area 67 CFC are some of the speakers.

And we can't forget....

SETA CFC will be hosting 3<sup>rd</sup> Annual National Corrections Conference in 2019 on November 1,2,3. Will be right here at the Double Tree. Got some awesome speakers lined up and the workshops will be over sponsorship, Cooperating with the professionals, a Judicial panel and a federal re-entry panel. There will be an inmate and ex inmate speaker panel with guys...maybe gals... that got the message on the inside. Will have a panel with a lot of past and present corrections chairs sharing their experience. Our Spanish speaker is the Director over in Tennessee prisons who, through a series of misunderstandings, got a life sentence and was kicked out of the country and he got his life back together and is now the Director of Volunteer Service and Chaplaincy in the Tennessee Department of corrections. It's an amazing story. So, Register if you can. Scholarships are available too.

- 2. These bells and whistles will allow SETA members to design their own pages and have access to SETA only content and information. This being said, in keeping a cohesive website, permissions will have to be restricted as to posting. We must maintain the ways that we will accept and share information.
- 3. Individuals not SETA members will see one thing and we will see another with our access!
- 4. Things will be the same in idea as to what the website will hold, however, it will look different. We want to make sure once the new website is released, everybody will have the opportunity to learn all about it and how it can be a great asset to how you function within your Area, we will be offering a showing or workshop event at the next assembly in October.
- 5. IT Committee participated in a workshop at District 70. We shared about the website and the many things you will find there. I would encourage all to take a trip into your Area digitally! The website in place now is packed full of everything from who your trusted servants are, where districts are, what service positions are available, what your committees do and events!

Final notes & reminders on submitting items for posting on the website:

- 1. To members submitting documents to be posted on the website: Please be advised the Area's Guidelines for the Website Prohibit us from publishing certain content, including last names, personal phone numbers and personal e-mail address. When we get these kinds of request, we have to reject the request and ask for it to be corrected.
- 2. While the rejections are slowing down, please reread and be familiar with the SETA Web Guidelines.
- 3. As well, make sure if you are submitting something for posting for your district, make sure to let your DCM know. We have received duplicates and information not shared correctly.
- 4. Also, make certain you spell the names of the individuals involved correctly.

#### District 10 – Katherine M.

Area Delegate Troy D., Alternate Delegate Kris H., and Area Chair Rick M. ensured that the last known contacts for all groups in District 10 were invited to attend the La Branch Street Group Conscience on June 22. After explaining service beyond the group level, an election was held and Katherine M, a past D10 DCM, was elected to start service. District 10 looks forward to engaging with all groups within the District.

#### District 20 – Jakalyn R.

- District 20 meets on the second Thursday of the month at 8:00 pm to 9:30 pm.
- Our July meeting gave us the opportunity to celebrate moving from 8 new GSRs in March to 16 in July. What is exciting is two of the 16 new GSRs were past members of District 20 and have come back as GSRs for different groups. As DCM I was astonished, at the increase when I counted the new GSRs last night. How have we been able to make this major increase?
  - We have amazing new members of District 20 that want to give back to Alcoholics Anonymous. They are fired up and committed.
  - Every month on the agenda we cover how we are doing with Dark groups. District 20 members will visit Dark groups, talk about being a GSR, and find ways to positively present the importance of the GSR in the A.A. Service Structure.
  - They are learning more and more about service, since we discuss a Concept every month. We have a person present the Concept for the month. Members read the Concept before coming to the meeting, and we have a discussion about what we each see of value in the Concept.
  - We have an informative flyer that describes what the position of GSR entails.
  - We talk about what we find are the difficulties of getting a group to elect a GSR and see if we can find a more effective approach. We have learned as we have been working on this, since January.
  - We had a Bar-B-Que at Lambda on April 27<sup>th</sup> from 12:30 to 3:00 pm to have people from District 20 to come and learning about being a GSR. We had large sign size copy of our Dark and Light groups, and people signed up to represent certain groups. Follow up was important, and that has resulted in us having 16 new GSRs.
- We are learning to use a simple set of Robert's Rules of Order that we developed and approved to help us to stay on track in the meetings, and we are having fun in learning how to use these guidelines. We review our list each meeting and encourage our members to test them out as a way to learn as we go through the meeting. One of the liaisons for our District is more knowledgeable about Robert's; therefore, he leads a discussion each month and increases our knowledge about the guidelines.
- We discuss a pamphlet each month. We finished the pamphlet— "The A.A. Group—Where it all Began" this month. A common statement was "I learned something I did not know by reading the pamphlet."
- On September 28<sup>th</sup>, we are having a workshop from 1:00-3:00 pm entitled: "More Will Be Revealed: What Your Sponsor Might Not Be Telling You." We will provide updates as we finalize our plans for the workshop.
- Beginning our meeting with the Serenity Prayer and ending it with the Responsibility Pledge has been well received. The Responsibility Pledge reminds us the reason we are volunteering to service in the District, since service is very important.

Another decision that was made in June is we have banned a person from attending District 20 Business Meetings. This decision was made in a group conscience, and lots of discussion, prayer, and consideration of A.A. literature has led to the following statements:

#### Traditions Related to Inappropriate Behavior and the ban of a Person at District Business Meetings

To begin the discussion of this topic, the following statements from AA Literature will hopefully assist in understanding District 20's study of the literature and establish our rationale in prioritizing a group's welfare first in relation to a single individual:

- Tradition One (The Long Form): "Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward. (Page 189, *Twelve and Twelve Traditions.* 
  - Page 129— "The unity of Alcoholics Anonymous is the most cherished quality our Society has. Our lives, the lives of all to come, depend squarely upon it. We stay whole, or A.A. dies. Without unity, the heart of A.A. would cease to beat..."
  - Page 130— "...that most individuals cannot recover unless there is a group. Realization dawns that he is but a small part of a great whole; that no personal sacrifice is too great for preservation of the Fellowship. He learns that the clamor of desires and ambitions within him must be silenced whenever these could damage the group. It becomes plain that the group must survive, or the individual will not."
- Tradition Three—page 144—the story of Ed gives us a great lesson. Ed hates the word God or Higher Power, and the A.A. group wants to exclude him. Ed gets a sales job and leaves. "At the end of a few days, the news came in. He'd sent a telegram for money, and everybody knew what that meant. In those days, we'd go anywhere on a Twelfth Step job, no matter how unpromising. But this time nobody stirred. 'Leave him along! Let him try it by himself for once; maybe he'll learn a lesson!'" In the next paragraph, "Ed stole by night into an A.A. member's house and, unknown to the family, went to bed. Next morning, he is at a meeting for morning meditation."
  - This story clearly shows that Bill W. accepted that a person can be rejected, and hopefully the person would learn the lessons needed. In this case, Ed changed when he was not helped by A.A. members.
- District 20 decided to remove a person from District 20 Business meetings. This individual has not been removed from A.A. meetings or other opportunities in A.A. We believe that it is the right of a District to decide that the unification of the District is more important than one person. The District also recognizes that other members of A.A. might find it important to support this individual; however, it is not their right to force a district to pick up their charge for "saving a person they designate as needing their help".
- District 20 is attempting to rebuild itself after having approximately 20-25 people at its meetings and dwindling to 4-5 people attending. Four plus years is enough tolerating, putting up with, and having members of A.A. who refuse to participate in District 20 after experiencing the behavior of the person now banned from District 20 Business Meetings:
- In the booklet, The A.A. Group- page 13 the following statements are made about who are members of Alcoholics Anonymous:
  - "Each group should be autonomous," our Fourth Tradition says, "except in matters affecting other groups or A.A. as a whole." So, predictably, each meeting held by our thousands of groups has its own imprint. District 20 has the right to create its own working environment to meet the needs of District 20.
  - As the long form of Tradition Three clearly states, "Our membership ought to include all who suffer from alcoholism. However, if the person is not an alcoholic, then this statement is made: "Nonalcoholic may attend open meetings as observers." This means that they do not speak in A.A. meetings. If a person has admitted that they are not an alcoholic, then even in open meetings they are not to speak. This would further help us conclude that they cannot be elected to any office in Alcoholics Anonymous and could be excluded from business meetings.
- Bill W. makes several statements in the book, *Language of the Heart*, about the fact that A.A. is not in the business of providing therapy. A.A. members need to accept that some members of Alcoholics Anonymous require more than A.A. can provide at various periods of their lives. Business meetings are different from regular A.A. meetings.

District 20's business is to provide services to the district, educate the GSRs about service and other aspects of the AA service structure so they can take back information that will help the A.A. groups they represent. District 20 meetings and events need to be safe places where they can do business and learn from each other and have fun while doing work that will benefit the district. The banning of a person from attending a business meeting is an acceptable action to take.

Hello SETA Assembly! I'm Patty and I'm an Alcoholic. I so very grateful to be serving as DCM for District 31! We are located in the Northeast section of South East Texas Area 67 and currently have over 36

groups. We meet every third Sunday of the month at the 494 meeting hall in Porter, Tx .2-4pm. Please stop by some time. We love visitors, GSR's, committee's, service, TRIVIA AND CHOCOLATE!

Our District is so very busy with fun and service.
