Treasurer's Report – Ron S.

- 1st Quarter Treasurer's Report was approved with corrections
 - Operating Fund beginning 01/01/2020 is \$71,812.11. Deposits to Operating Funds is \$19,629.90. Checks written on Operating are \$15,332.43. Net change of \$4,629.90. Total Bank Balance Ending 3/31/2020 of \$76,442.01.
 - First box is our Operating Funds broken down by each quarter.
 - Second box is our SWRSSA Fund broken down.
 - Third box is our Convention Fund broken down which shows an ending balance as of 3/31/2020 is \$2,500.
 - Funds Ending Balance as of 3/31/2020 is \$76,442.01. Convention Loss Reserve is \$4,000; Convention Fund is \$15,000; State Convention Loss Reserve is \$3,000; Prudent Reserve is \$34,828.73; Unrestricted Funds according to the latest bank statement is \$19,613.28.
 - Second page of the report reflects everything that was spent for the year.
 - Last three pages of the report are the breakdown of group contributions for the 1st Quarter.
 - Corrections to 1st Quarter Treasurer's Report include: Convention Fund should total \$11,500;
 Unrestricted Funds should total \$23,113.28; Grapevine expenses for 1st Quarter should be \$296.70 reducing their Budget amount to \$785 with a Difference totaling \$488.30.
- 2nd Quarter Treasurer's Report was incomplete due to error in numbers found while presenting by Ron S. and Kris H.
 - Rick M. stated that the 3rd Quarter Treasurer's Report will be corrected and submitted at the October 2020 Assembly for approval
 - o Mike D. asked that Ron S. email the 3rd Quarter Treasurer's Report out once all corrections are made
- It is time for SETA to file taxes and due to the Treasurer's computer being stolen all necessary Expense Reports and Bank Summaries were lost with the computer; Request to all budget holders to submit a copy of your 2019 Expense Forms
- Online Contributions for SETA has been setup through Zelle; an email was sent out via SETA Announce with link
 to Zelle and instructions for group and/or district contributions; in the contribution email, it needs to be list the Group
 Name, the District Number and the Group Number to make it easier to credit the individual group; a new, separate
 account was setup for the Zelle contributions so that our Operating Account and/or Savings Account is not affected
 in the event there is a security issue

NEW BUSINESS

2021 Propose Budget - Michelle H.

- See complete Proposed 2021 Budget and 2021 Pie Chart: Mandatory v. Discretionary Expenses on the SETA Finance page: www.aa-seta.org
- According to the pie chart, 76% of budget is mandated through the P&P manual for contractual agreements such
 as hotel or venue contracts for assemblies, conventions and assembly actions; this percentage is predetermined
 before the Budget Committee even meets; Budget Committee only has 24% to work with when coming up with
 the upcoming year's budget; Proposed budget has decreased over the last 2 years due to budget holders working
 hard towards a practical, healthy finances for the Area
- An amended Proposed Budget was emailed earlier this week due to our Regional Trustee, Jimmy D. informing
 our Delegate and Alt. Delegate that the 2021 Regional Forum had been cancelled; this took \$4,200 out of our
 budget immediately, which is part of our mandated budget
- Original proposed budget was \$58,328.00 and has now dropped down to \$54,128.00 due to 2021 Regional Forum being cancelled
- We are able to fully fund at least 1 national workshop per year, possibly all of them; Archives is the approved committee for 2021
- We have fully funded the delegate for 2019
- A lot of our budget holders were able to cut expenses due to reduced printing costs
- 2021 Proposed Budget was approved as submitted

Floor Action - Virtual Assemblies and 3rd Legacy Voting - Rick M./Christina S.

- Issues:
 - Zoom polls cannot handle more than 10 choices
 - No easy way to control who votes
 - o Integrity of the 3rd Legacy procedure will be difficult to maintain

• Possible Solution:

- o Tech 12 provided 3rd Legacy voting support at the General Service Conference
- o The owners are AA members who understand the 3rd Legacy voting procedure and its importance
- A "voter's room" and an "observer's room" would be utilized, ensuring integrity

Discussion Points:

- A typical Assembly weekend costs about \$3000; Tech 12 will cost \$2,975 (See page 16)
- The Area has saved about \$6000 by not holding 2nd and 3rd quarter Assemblies at the Sheraton North Houston
- Tradition 8 Long Form: Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we might otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual A.A. Twelfth Step work is never to be paid for. Reprinted with permission of A.A. World Services, Inc.
- Finance Committee was poled on this expenditure and they were unanimously in favor of using Tech 12

Q&A

- Elle Is it possible to use the "raise your hand" feature in Zoom for the elections?
- Rick M. With 3rd legacy voting there is usually more than 10 people standing for any one position and Zoom is only able to list 10 people; Plus we couldn't do it by secret ballot since the virtual hand raising would be visible to everyone

- Troy B-D. talked about his experience with Tech 12 at the virtual 2020 General Service Conference; they spent an amazing amount of time with GSO staff, Trustees and Delegates before conference started in training; they do an amazing amount of work and are very professional; the way that they handled our elections for trustees was seamless voting members and those invited to participate were moved into a separate voting room and all other non-voters were observers. It was like a zoom meeting within a zoom meeting.
- Allise B. stated that the IT committee is not equipped to handle the election procedures virtually and if we
 have a solution by using Tech 12, she's all for it!
- Peter C. stated that this was too much for our IT committee to handle and rather than trying to reinvent the wheel, we could make use of a company that is already established in handling the online voting process and a good use of our funds.
- Veronica raised a concern that the \$6,000 that is being saved is the group's money and this Tech 12 solution should be taken back to the groups if we are going to spend the money this way; her second concern was us having to pay the hotel for the 2021 SETA convention in spite of the pandemic and the possibility of losing money on the 2021 SETA convention; would it be possible to do the elections on a different day than at the October Assembly. Rick stated that we already have the elections on a separate day than the Assembly itself; all of our business is taken care on Saturday; he neglected to say earlier that Tech 12 is available for the Sunday of our October Assembly. Per our preamble and Policies & Procedures manual, we do have a substantial convention loss fund, restricted just for the purpose if our convention loses money.
- Marshall W. stated that the IT committee has worked out a spreadsheet for elections and it took them a couple of years to develop it, so it wouldn't be feasible for them to come up with a virtual solution before October. Question for Troy Was there much of a learning curve for the voters? Troy responded by saying he wasn't a voting member this year for the GSC so he doesn't know what kind of learning they had to do. He can find out, he just won't' have a response today.
- David stated that he didn't want to figure it out on election day. Finance committee has approved it, seems like the IT committee has approved using it. We aren't publicly endorsing it, we are just using it like another tool, like Zoom which is just to help better assist our trusted servants do their jobs.
- Deborah D. asked if we could "Call the Question" for approval to spend \$3,000 to do our voting in October; Vote totaled 48-For and 7-Opposed; Debate is stopped based on the votes.
- While waiting for the Call the Question vote, Mike D. raised the point about possibly having a list of candidates available prior to the election day to be better prepared. Christina S. stated that she let Tech 12 has handled areas with over 600 people and they were told how we handle our Third Legacy elections. Tech 12 is prepared to add candidates in real time. Rick M. stated we will be able to use Mike D.'s hat if we have to take the vote "to the hat".
- Tony W. made a motion that we use Tech 12 for our October Elections; Kris H. seconded the motion. Vote totaled 56-For and 1-Opposed

The purpose of the Literature Committee is to raise the awareness for A.A. Conference-approved literature, audiovisual and other special items.

The Area literature committee has been meeting the 3rd Tuesday of each month from 8:30 – 9:30 PM using ZOOM online meetings. We also meet during the quarterly SETA assemblies at 4:30 PM on Saturday under normal circumstances. In April, we took a hard look at our situation and asked ourselves, how are we fulfilling our committee purpose during this pandemic individually? How can we do more as a committee? District 20 – Jakalyn R.

- We have initiated different GSR Sharing Sessions at our meetings. Each person attending can talk about where
 they are with this crisis of the Coronavirus, and what they feel about their particular situation. This is important
 and the members of District 20 have stated that they value this opportunity to talk about where they are. This
 helps clear them of the issues they are facing and getting support from the other members. GSRs then gives the
 name of the group they are representing, time and place for the meeting or if their meetings are virtual during the
 pandemic, and
 - anything else the GSR would like to share about their group. (A group may have more than one meeting a week).
- Dark and Light Groups in the District: We have continued to make efforts to contact the dark (no GSR) groups, which are now online. We are making efforts to join some of the Zoom meetings to invite the groups to elect a GSR.
- We continue to have a member present a Tradition and have a lively discussion about the application of the Tradition to our personal lives and how we participate or we are involved in Alcoholics Anonymous.
- We have two workshops that we are very excited about that have been approved by the district. We also are
 going to talk with the Lambda Round Up Committee to see if we can make some changes about the location of
 our table at the Round Up. We want to be sure it will provide us the greatest opportunity to contact potential
 members of A.A. that could be GSRs for their groups.
 - "Building Connections-Social and Emotional Recovery" was our first Zoom workshop presented using Zoom in three sessions on June 18, June 25, and July 2, 2020. Jackalyn R. and George S. were the facilitators of the program. Our breakout room facilitators were Joe. D, Laura H, Linda S. and Sharon H. It was remarkably successful. We had a great time providing this program, and the participants indicated that they thoroughly enjoyed the workshop and the breakout rooms. It was so successful the participants asked if we would provide it again, and so we will be offering it on September 12th from 1:30 to 4:45 pm. Please see the Feedback that we received from the participants:
 - QUESTION: What session(s) in the three-part workshop did you attend?
 Most respondents attended all three sessions except two, who attended two out of the three sessions.
 - QUESTION: What did you find most helpful about the workshop (please be specific when possible)?
 - Relating to Self and Others handout and exercise were helpful spend more time; Feeling Circle chart very helpful; 12 Traditions Illustrated helpful
 - Practical suggestions: breakout room opportunity to share. Nice feature
 - How organized everything was.
 - The lesson about clearings and effective communication (session 2) was extremely helpful in going forward in my relationships.
 - Meeting new AA members; practicing I- statements with partners; the Feelings Circle; Clearings, and how to do them; maintaining relationship with self, sponsor, others by identifying feelings; seeing/hearing the examples of communicating with others (e.g. "I really value your friendship."); and the revelation that we can Name the Feeling, Process the Feeling; and Express the Feeling, and "...getting down to the cause of the condition..." for the purpose of working on Step 10.
 - > (Recognizing) that interrupting is common problem.
 - > I want to sign up to take this workshop again!
 - ➤ I loved clearings. There seems to be something missing from the parts, maybe a fifth part that has to do with connectedness, or maybe that's spiritual; maybe its relational.
 - I loved getting all the handouts. They are really helpful.
 - > I liked the listening/receiving response examples. I want to practice them in 'real life.'
 - I loved the group--conviviality and learning and growing. That's my kind of space! Everyone seemed focused and friendly and vulnerable and I felt comfortable, if not a wee bit anxious because I am always a bit nervous in settings with new people. But Jackalyn and George made it comfortable for me because we had a purpose and that grounded me.
 - Seorge's email communications were outstanding. Timely, informative, and kept me motivated to keep going, plus I love handouts! Glad to have the clarification on Grapevine that can be shared with others. I think it's a great resource because it comes from the AA community, and I have experienced groups feeling inhibited about reading from the Grapevine at meetings, etc.

- Learning different ways to show someone you are listening. I also very much liked the handouts from the first couple of days. Also, Jackalyn's feedback in breakout sessions was both helpful and very encouraging.
- QUESTION: What would you suggest changing about the workshop?
 - I would have loved having more time in each breakout session.
 - I would suggest the notes that were taken during the breakout groups be sent out to everyone. Our group had some great ideas. I'm sure the other groups also had some we didn't think about. But we didn't have enough time to discuss them with the whole group.
 - The 12 Steps Illustrated was not worth printing 55 pages not necessary.
 - The AA Group handout was good to know, but outside the scope of Social & Emotional Recovery workshop so we spent too much time on it.
 - ➤ The meetings could be longer 1.5 hours with 2 meetings.
 - The email notices should include instructions of which handouts should be read ahead of time for meeting. Spend more time on the Clearings what is the source or background of the process?
 - I recommend that participants print out only immediately relevant handouts. It was important to review them ahead of time, but not necessarily to print out all of them, especially the lengthy ones.
 - Please have all facilitators remember who they're talking with in their groups. A girl yesterday said she's just 2 weeks into the program, but was asked questions as if she's had any opportunity to have any idea how the traditions help in her regular life.
 - Not sure if I would attend a 3-hour, one-night workshop, but perhaps maybe others would. May I suggest 1.5 hours over 2 nights?
 - Psychic Change I liked the inclusion of psychic change from 'The Doctor's Opinion,' but I am still a little unclear on just exactly what a psychic change is and how one gets there. It would be helpful for me if there were some separate explanation of that term might help me understand at a slightly deeper level what a 'psychic change' entails.
 - For the next workshop, you mentioned thinking about 2.5 hours rather than 3 1-hour sessions. Mixed feelings about that, but I've been in successful 3-to-4 hour workshops. Probably a trade-off, as it's hard for some folks to block-off 2-3 hours at a time. In my case, I was happy to catch 2 out of 3. But you have a lot of material, so if you go for one session, I suggest blocking off 3 hours, with a break in the middle and willing to end early if participants run out of steam. Just my thought
- Feedback for both Jackalyn R. and George S.
 - > Nothing to suggest. You both did a great job, and the Session 1 facilitators were also very good.
 - Great job, thank you for your service and I will be looking forward to your next workshop.
 - Such an excellent workshop! Excited to tell friends about future workshops.
