The SETA PI Committee would like to propose that SETA fund several outdoor public service announcements to inform the public on how to communicate with Alcoholics Anonymous as follows:

4 public service announcements of the Bulletin', 2 in English and 2 in Spanish. The only difference between public service announcements in English and Spanish will be the contact number/website.

Vinyl newsletters cost (14'x 48') \$500 installation fee/each

Printing costs \$325 per vinyl (lasts approximately 18 months and can be reused)

Approx. Cost for 4 PSA newsletters \$3300.00

Clear Channel Outdoor will also include, at no cost, 2 digital public service announcements (14'x48') 1 in English and 1 in Spanish that will run on 32 panels across the metropolitan area.

All digital boards are located outside the city of Houston. The digital panel rotates every 8 seconds and can be viewed 1250 times a day.

note:

- 1-Projected costs are for print and installation labor-Advertising space will be donated
- 2-The locations for the newsletters are on and off the city limits of Houston.

We may request specific areas and will attempt to adapt, but utility announcements will be installed as space becomes available.

- 3-Normal runtime for donated PSAs is 28 days but can be advanced if space is sold commercially. Vinyl Bulletin's utility ads will be moved to another location if ad space is sold. Digital utility announcements will be installed as the board space becomes available again.
- 4-The committee would like to coordinate this project with District 81, as they have approved a smaller PSA project to be published on the neighborhood poster panels (12'x24) on the district's secondary roads. The PSA used will be the same. All necessary paperwork can be sent at once.

Literature Committee Chair Report 7-10-2021

My name is Hilton, and I am an alcoholic. It is my honor to serve as your SETA Literature Committee Chairperson. The purpose of the literature committee is to raise awareness for AA conference approved literature, audiovisual, and other special items.

I would like to appeal to you today to take a chance on doing something that might be different for you. That is to include a piece of AA conference approved material in an AA meeting. Sure, we have plenty of Big Book and Twelve & Twelve studies, but this is a little different. It is to use an AA pamphlet to lead a meeting.

If someone has not done this before, there can be uncertainty on how to go about it. I know I had to get outside of my comfort zone, which is what my sponsor calls growth! Good positive coaching from a helpful group members made a big difference, too. Our committee members are now gaining more experience in this endeavor as part of our committee activities and are willing to help anyone in getting started. Some of the pamphlets lend themselves better as being topic material. We can make suggestions on which ones have worked well.

Another way of using pamphlets in a meeting is to present a short highlight on one. I like to do so when there is still time left during the announcements so as to not interfere with sharing. It can be tied to the meeting topic, or maybe something else that could be addressed. I like to use my imagination, especially with the illustrated ones. This works well especially when newcomers are present. They see that someone is making an effort to help them. A pamphlet can also help back up things I say, so it's not just coming from me. And isn't this what we should be doing, shedding positive light on our program to the new person?

I can speak with others such as sponsees and home group members about using these meaningful publications. My face-to-face home group has just started doing a pamphlet study. The pamphlets are available to view for free on AA.org, and so can be accessed on a phone, which is handy.

It works well in both venues. The online group that I attend has been doing these pamphlet presentations for over a year. This group really enjoys doing this and has made a designated day of the month for having a pamphlet study. Screen sharing material from aa.org is possible, and really adds to a virtual meeting.

I had the privilege of giving a talk at a District 70 meeting recently, and several people liked these ideas. Most of the meeting topic pamphlets I brought were gone at the end.

Did I mention that one does not need to be a literature committee member or literature rep to give a pamphlet presentation? We can all participate in helping share awareness of AA Conference approved literature!

The Literature Committee meets online the third Tuesday of the month. Let me know if you want the contact info.

If anyone wants to know more about the AA pamphlet presentations, there are packets of publications for this purpose at the literature table. Pamphlets are free. So, drop by to see, and to ask questions.

Multilingual Committee Coordinator report

Hello, my name is Severiano M., and I am the Coordinator of the Multi-bilingual Committee, and I have the valuable help of Deborah D., Past Delegate and Rodrigo A., Past Delegate in Colombia. This Committee made plans to visit our Hispanic Districts. On April 25, 2021, Companion SAL from Beaumont TX called and invited us to the Multi-bilingual Committee to participate in the Convention in Beaumont, TX on August 20-22, 2021. Then Companion Sal called to confirm that there will be a room available for meetings in Spanish.

The Multi-bilingual Committee was asked to find a speaker for our SETA Convention in January 2022. On the date of May 4, 2021, I contacted the Puerto Vallarta Intergroup to find a possible Speaker by the name of Enrique P. The Secretary Intergroup, I contacted the Puerto Vallarta Area and the server Violeta R. put me in contact with the speaker Enrique P.

He contacted the DCM of District 64, who informed us of a meeting in District 63 with the other DCMs of Area 67. Area 67 Public Information Committee Report, July 2021 Assembly

The Public Information Committee has had a busy several months. We are very excited about the upcoming vote on the Billboard PSA proposal.

We serve to continue our work in spreading information on what AA does and does not do and where to find us. Our primary purpose continues to be to carry the A.A. message to the alcoholic who still suffers.

Read proposal to the assembly

I would like to share something a friend and fellow trusted servant shared with me. There are approximately 7 billion people currently living here on this earth.

An increase of how many over the last 30 years.

If 10% of the population is alcoholic, then there are roughly 700 million potential alcoholics. If you would like to use a conservative 5% then there is 350 million alcoholics currently living on this earth.

Yet, our beloved A.A. Fellowship has remained at approximately 2 million members for the past 30 years. 2 million out of a conservative 350 million.

Why has our fellowship numbers not grown in 30 years? a

There are many reasons for sure and one of the largest is lack of Public Information and Cooperation with the Professional Community.

The general population does not even know how to contact A.A. or how to find an A.A. meeting.

Our CPC Committee gave presentations to the major hospitals in Houston prior to the pandemic and 8 out of 10 medical social workers did not know how to contact A.A. in Houston or where any meetings are held.

The billboards are not sensational advertising. We are not saying "buying 3 big books and we'll give one fee" or "bring a friend to a meeting and we'll discount your membership dues"

The purpose of the billboards is to provide Area 67 contact information to the general public.

The same reason Area 67 did them 25 years ago and the same reason as an A.A. phone number listing in a phone book.

I thank him for sharing his thoughts and bringing perspective to the issue of PI and CPC experience

Currently in Area 67 there are roughly 6 million people, which means there are at least 300,000-600,000 alcoholics. How many of those 300,000-600,000 alcoholics know where a meeting is held? Or how to contact A.A?

The Public Information Committee is currently rather small, but we have a lot of willingness to serve. Our members have shared the wonderful outreach going on in their districts and groups. Including placing ads in local papers and magazines about where to find AA and local intergroups. Several Adopt-A-Rack requests have been made and subsequently placed. We are looking forward to the community health fairs starting up soon.

We are looking into learning more about digital media platforms. I am looking forward to the future of public information and the many new avenues that are available.

Also, one of our committee goals is outreach to districts and groups for workshops on Public Information. One member suggested simplifying the how's and why's of public information to area groups to increase awareness of the need to reach out to the public and increase committee participation.
