 - 2-3 Hospitality Suites suggested
 - Used to have 4 Hospitality Suites every year
- Committed to meet certain % of hotel expenses as Food and Beverage
- Considering box lunches on Saturday, Saturday night banquet and snack bars that would be run by hotel
- Have suites reserved for Hospitality Suites, but must be sponsored by Districts
- o D81 would like to offer a hospitality suite as they have previously
 - Has done this in a room on the 9th floor previously
 - \$650 budgeted by District
 - No cooking allowed on upper floors, but hotel does not complain about packaged food and fruit
 - Hotel asks that we not offer coffee upstairs because it competes with the coffee they are selling us; lemonade and soft drinks can be offered
- 2 suites, each with a connecting room on the first floor currently reserved
- All four Hispanic Districts together will sponsor a hospitality room
 - D64 will be the host District within combined committee
 - Luis P. will be Chair of the combined committee
 - The four groups have appointed Marco ___ as the liaison to the Convention Committee

- We can book the entire hotel; committed to fill 70% of the hotel

Delegate's Report - Rick M.

I want to thank you for this opportunity to serve our Area. Since our October elections, Past Delegate after Past Delegate

informed me that I was going to become very busy after January 1st. They were not wrong as this is the busiest I've been since retiring quite a few years ago. The thing is though, I am loving every minute of it. This is the most fun I have had in your service and that is saying something because I have enjoyed every single position that you have entrusted me with. I will say, however, that my respect for our Past Delegates continues to grow because I don't know how they found time to do this job while working full time.

We received the final GSC agenda and background material on February 15th in all three languages. The Conference Coordinator and the brand-new Translation Department did an outstanding job getting that information to us in such a timely manner. You may recall that by advisory action of the 72nd GSC, the agenda and background must be released simultaneously in the three languages of the Conference. The Final Agenda consists of 85 items and more than 1000 pages of background material.

I want to thank all of you who participated in the Roundtable discussions yesterday and I look forward to hearing the report back here shortly. This makes each of you a part of the Conference process, a very important part. I especially want to thank the facilitators and recorders. Your willingness to serve our Fellowship is very gratifying. Every single person I asked to be a facilitator agreed immediately or if they had a conflict supplied a substitute. The April Assembly has long been my favorite Assembly because we get to have these discussions.

I want also to thank all our DCMs and MCDs for allowing Christina and I to visit your District Committee Meetings. Our purpose for the visits has been to solicit feedback from groups and committees for agenda items and the response has been very good. This too is an important part of me going to the Conference as informed as I can possibly be. I will leave for the Conference on Saturday April 22nd, so there is still time to provide feedback on your favorite agenda items up until then. A special shout out to Enrique, Cristian and Dulce for providing their translation services when we have visited our Hispanic Districts.

The weekend of March 10-12, I had the privilege of attending my first in-person SWRDA (Southwest Region Delegates Assembly). What an amazing weekend! The primary purpose of SWRDA is to prepare the Regional Delegates and the Alternates for the Conference. Our Past Delegates commit their time at their own expense to attend this event out of love for our Fellowship and the Conference. One of the things I learned is that this event is unique, and no other Region holds such an event. It speaks to the love and commitment of our Past Delegates for AA and our Region.

Now to the General Service Board and the resignations from the Board that have taken place. Some of my fellow Delegates have faced criticism from their Areas for a lack of transparency and communication in this unfortunate matter. I know that I have not shared much information because there simply has not been much solid information to share. Everything I have shared with you is either a first-hand account or an official statement and not some outside person's opinion. I realize that there is a lot of noise out there on social media. I refuse to read any of that or participate in any of it. This issue is something that the 73rd General Service Conference will have to deal with and the hope among our Region's Delegates is that we won't be diverted from our primary purpose by this controversial issue. The Delegates have had multiple meetings with the Board in search of accountability and transparency. We are not convinced that we have received either. More will be revealed.

One of my responsibilities is keeping y'all informed of <u>Regional Events</u>. The <u>76th Annual Texas State Convention</u> will be **June 9 to 11** this year at The <u>Westin San Antonio North</u> in San Antonio, TX. The <u>Southwest Regional Forum</u> will be this year <u>September 29 to October 1</u> at the <u>Radisson El Paso Airport Hotel</u> in El Paso, TX. I think one of the most common questions asked is what exactly is a Regional Forum. Have you ever said to yourself, "Who are those people in 'New York'"? I wish I could talk to them one on one." Well the Forum is your opportunity. Regional Forums allow AA members

to connect with people throughout the service structure. We get to exchange information with representatives from General Service Board, A.A.W.S., AA Grapevine and G.S.O.

The last thing I want to talk about is **SWRAASA 2026**. SWRAASA is our Southwest Regional AA Service Assembly. It happens in October in even number years. SWRAASA 2026 will be hosted by Area 67. Beginning the second Tuesday in April, I will be sitting in on Area 68's SWAARSA Committee Meeting to see what they're doing to get some ideas of what might be best for us. 2023 SETA Convention Guidelines Ad Hoc – Joel G.

- Purpose is not to rewrite guidelines but to fill in gaps so that new Convention Committee Chairs know what they need to and transitions can be as smooth as possible
- Considering a "need to know" section for tidbits that would be helpful to new Chairs
- Start to electronically archive all the records, emails and documents to provide records and guidance to the next conventions in the coming years?
- Collaborating with several past Convention Chairs
- Guidelines have not been updated since 2016

Position Holder Email Update to SETA Webpage Ad Hoc — Christina S.

Bella created an ad hoc committee to review the updating of service position committee position holders after the elections and throughout the year as new people stand for area committee positions or others leave position, both on the webpage and AA seta emails.

A big thank you to Tiffany S., Brad H., and Cheryl M. for all their hard work. To ensure uninterrupted communication, the G-Suite position-based emails and the SETA website are the two areas that we identified as needing updating. We looked at three key items that we believe will achieve this.

First item we reviewed was the updating of service positions after the full slate of panel elections have been done. This occurs in the 4th quarter of even-numbered years. The Committee recommends:

- Two weeks after the elections the Registrar will send all newly elected members' email addresses to the IT committee.
- The IT Committee will update G-Suite position-based emails no later than two weeks after the Registrar sends email addresses to them. The position-based emails will be updated to include both the current and incoming elected position holders.
- The IT Committee will update the SETA website two weeks after the January SETA Convention. The update will include adding all current newly elected area committee member names to the website. They will also remove all past position holders from the website and G-Suite position-based emails.

The next item we discussed was updating of service positions during a current panel. This would be anytime a trusted servant is elected to a position that is not in the 4th quarter of even-numbered years. The committee recommends that

the IT Committee update both G-Suite position-based email and the SETA website no later than two weeks after the position is filled.

The last item we looked at was verifying that emails are working correctly. Our IT Committee is working on a process to verify the position-based emails are working correctly.

Our committee will be bringing motions for the Assembly to vote on in July. Thank you Bella for allowing me to serve.

Mesa 1 — Yolanda (19 members)

- VI(O) Literature—Options that will be more attractive to young people than a paper pamphlet: Instagram, Facebook, Tik Tok, illustrated brochures; Instagram is the main option
- VIII(R) Public Information AAWS Instagram Account: Yes, implement it. Social media is a primary method of reaching people now.
- X(E) Treatment Facilities Consider doing an accessibilities inventory: Unanimous yes.
- XIII(C) International Conventions & Regional Forums Should the big meetings at the International Convention end with the Lord's Prayer, Serenity Prayer or Responsibility Statement? 15/19 members with 1 abstention voted for the Responsibility Statement, with 1 for the Lord's Prayer, and 2 for the Serenity Prayer

Mesa 2 — Luis P. (18 members)

- V(D) Grapevine Should Alternate Delegates have access to the same material as Delegates (esp. on the Delegate's Dashboard)? 18 in favor, 0 opposed
 - Very important for Alternate Delegates to have the same material as Delegates in case they unexpectedly need to attend the GSC
- VIII(R) Public Information AAWS Instagram Account: 15 in favor, 2 opposed
 - Good to do it with care not to break the Traditions
- IX(C) Report & Charter Anonymity-protected Final Report posted on aa.org: 15 in favor, 2 opposed
 - Good to do it with care not to break the 11th & 12 Traditions
 - Concerned that the print version comes so late that they can't check information so it would be beneficial to have faster access

- III(C) CFC-<u>Service Material on Safety SMF-209</u>
 - Background Info: changed in 2017, again in 2021 & 2022
 - 4.5 pages about LGBTQ community & issues regarding diversity and inclusivity
 - \circ Q1: 4-7 Q2: 4-10 disagree with keeping the 2022 version–should revert to 2021
 - Arguments for reversion:
 - AA rules are not needed
 - Our autonomy Tradition means these language items don't have to be posted
 - Issues regarding diversity and inclusivity create chaos in the groups
 - Minority Opinion: Groups and sponsorship can deal with this don't like flip-flop
 - Good background information for groups on how they can deal with these issues
 - Tradition 3 covers issues of diversity and inclusion—additional language is unnecessary
 - Person should be aware of racism and sexual orientation issues dividing groups affecting newcomers

- We are not above the law
- Majority agree it requires further consideration
 - Shorten language-5 pages is too long & not all definitions are required
 - Include statement about group autonomy
 - Discussion to be less long-winded
- IV(A) Finance—Clarify that GSB receives contributions and GSO processes them: 10 for, 1 against
 - Literature should be consistent and people should know where their money goes; clarify as pamphlets are reprinted
- VI(M) Literature-
 - Should the final draft of the Plain Language Big Book be reviewed by the entire Conference instead of the Literature Committee only? Unanimous: entire Conference should review as a bulwark since a third party is preparing this translation
 - Should the plain language project be canceled? 3 cancel, 12 keep
 - If even a people are helped, it's worth the effort
 - Minority opinion: cancel because non-AA party translating our Book and sample in last year's Background Material was confusing; afraid of message of recovery being diluted
 - Majority: emphasized this is a translation, not the Big Book; review by the entire Conference should mitigate inaccuracy issues
 - Second Vote: 2 cancel, 13 keep PLBB
- VIII(R) PI-AAWS Instagram Account 13 for, 1 against
 - How are we going to contact millions of Alcoholics without social media? Can easily let millions know information about Fellowship issues, provide links to literature, meetings, Grapevine, etc.
 - Anonymity protected by selecting options to discover who follows or "likes" posts
 - We and Trustees should use it—GSB could use internet to more transparently communicate with the Fellowship and ask for input on time-critical issues between GSCs
 - Minority opinion: a GSB member could use it to express minority opinions and could create anonymity breaks and abuse by GSO/GSB
 - Must have PI oversight to follow Guidelines
 - Can't be Trustee's decision only
 - All agree committee should be formed for approval of Instagram posts, including IT Committee in decisions

- II(D) CPC-Retire Member's Eye View pamphlet P-41: 11 in favor, 1 against
 - o Pro:
- Written decades ago
- Does not represent the wide range of spirituality of AA as a whole—the pamphlet is too narrowly focused; Christianity is 1 religion—others may feel alienated
- Minority opinion: by removing Christian dogma, we may alienate Christian members
- IV(F) Finance–Revisions to 12x12: 7 for, 5 against
 - Majority:
 - Would removing "rape" leave a disconnect with men who have raped?

- "No one should ever consider changing Bill's writing because it is opening a door that is dangerous"—slippery slope
- Fewer people may have been informed because it was done during COVID
- Could alienate some women
- After Minority Opinion 7-5
 - Does "rape" make women feel unsafe?
 - Maybe change "rape" with an asterisk for explanation that rape has nothing to do with lust
- "Opposite sex" to "Partner" pg 113
- Pg 66 "angry enough to murder" to deadly sins
- VI(O) Literature—Cost-effective media options as an alternative to reach young people: Did not vote on any suggestions
 - o Graphic style pamphlets could be used
 - Suggestion from ICYPAA
 - Should there be a liaison committee with ICYPAA?
 - Should the Conference recognize ICYPAA?
 - Game-oriented app
- VIII(L) PI-Paid placement on streaming platforms 12-0 in favor
 - Positive transition and way of outreach, esp. for young people

- II(D) CPC-Retire Member's Eye View pamphlet Unanimous: disagree with retirement
 - Discussion about religious content, but noted it is only one person's view
 - Pg. 5 clearly explains that it is from 1 member and does not reflect the entire Fellowship
- VI(M) Literature–
 - Should the final draft of the Plain Language Big Book be reviewed by the entire Conference instead of the Literature Committee only? Unanimous: entire Conference should review
 - Learned that there are 9 members on the Literature Committee
 - Being written by a non-alcoholic vendor
 - Should the entire project be canceled? 8-5 yes
 - Waste of money to rewrite what has been written so well
 - Not a translation but a rewrite because it is English to English
 - Minority: trust in the trusted servants to say it's good enough to be continued
- V(D) Grapevine Should Alternate Delegates have access to the same material as Delegates (esp. on the Delegate's Dashboard)? Unanimous yes
- IX(C) Report & Charter-Online anonymity-protected Final Report: Agreed unanimously
 - O Digital Report already available, issue is whether it is on aa.org

- II(D) CPC-Retire Member's Eye View pamphlet 11-0 to retire
 - Prefaced in beginning as one man's take
 - Directed to professionals
 - Similar to stories in the back of the BB
 - Could remove paragraphs that have heavy Christian influence
 - o Cut funds from this pamphlet could be directed toward other useful resources

- IV(F) Finance–Revisions to 12x12: 8 for, 2 against
 - Page 66 shows the harshness of disease; softening the language could tarnish the truth
 - Revisions dilute text that has worked for millions
 - AA didn't create the trauma and isn't responsible for triggering; leaned toward reality
 - If both must be voted together, it is to rescind, but "partner" does not offend as a change
 - "Partner" is an outside issue—each group is autonomous, protected by Tradition
 - the changes impact unity and affect primary purpose with controversy
- VI(O) Literature—Too Young: 1 vote against pamphlet, 10 votes for developing media
 - Outdated pamphlet
 - Develop app to reach high school & college age—a version of Bridge the Gap that allows young people to connect with each other
 - Attraction rather than promotion, not visualizing consequences with frothy emotional appeal
 - Approaching social media platforms
- XIII(B) International Convention—21 non-AA speakers: 9 in favor, 2 opposed
 - A lot of money–minimum \$73K
 - Understood that benefits are worth the expense
 - Trusted professionals have always been invited and are useful

- II(D) CPC-Retire Member's Eye View pamphlet: 7 retire 5 keep
 - Keep: personal story designed for use with professionals; aligned with BB
 - Retire: some may not read disclaimer that it is a story
 - Could give the false appearance that AA is Christian-based
 - Minority opinion: Perhaps rename the pamphlet
 - Pamphlet is specific for use in professional setting
 - Christ is mentioned in the Big Book and it is a personal story
- VI(M) Literature—Should the final draft of the Plain Language Big Book be reviewed by the entire Conference instead of the Literature Committee only? 10 full Conference, 3 Literature Committee only
 - Full Conference review for transparency and due to controversy of this edition of the Big Book
 - Conference is composed of our trusted servants who will assure the words are in alignment with the Big Book and alleviate arguments
 - Minority opinion: Would be a smoother transition if only Lit Cmte reviews
 - Keep project 7 keep, 5 cancel
 - Pro cancellation: didn't know where idea came from—cancel because of lack of transparency
 - BB is in old English but good sponsorship should be able to fill in the difference
 - Easier, softer way and people won't make it to the old BB
 - Keep pro: everyone should be able to get sober; the wording is difficult
 - Good addition—trust the Conference
 - Next generation should be able to understand the Big Book

- XIII(C) International Conventions & Regional Forums Should the big meetings at the International Convention end with the Lord's Prayer, Serenity Prayer or Responsibility Statement? 7 for Chairperson's choice, 1 for the Lord's Prayer, 1 for the Serenity Prayer, 0 for moment of silence
 - Moment of silence: more appropriate for a big group of people with such a diversity present
 - Responsibility Statement: primary purpose and includes everyone
 - Lord's Prayer: spiritual experience
 - Speaker could choose for continuity
- III(C) CFC-Service Material on Safety SMF-209: 12 adequate, 1 not adequate
 - Material could be added; 2021 was more direct on verbiage
 - Recommendation: SMF-209 be considered a pamphlet and go through the Conference process

- IV(F) Finance–Revisions to 12x12: Page 117: 8 for, 8 against Page 66: 12 rescind, 4 keep
 - Keep founder's words
 - Positive reception of the focus on Inclusivity
 - Use footnotes for any updated language
 - Frustration about not being involved when the change was made
 - Each page voted separately
 - Addition comment: "rape" may be contentious with newcomers
- VI(O) Literature—New Ideas for <u>Too Young pamphlet</u>: No vote was taken as the ideas provided were collected for our suggestion
 - o Floor action 2017
 - Started by ICYPAA
 - On hold due to \$100K
 - Suggestion: omit color and go to single-page pamphlet with QR code that directs to an interactive digital media landing page that can be easily updated with new content

Archives - Deborah T.

Hello brothers and sisters, good news, I'm back for another two years.

It is my honor and privilege to be serving as the Archives Chair for Area 67.

Mission Statement: The mission of Area 67 Archives Committee is to document permanently the work of Alcoholics Anonymous, to make the history of the organization accessible to A.A. members and other researchers, and to provide context for understanding A.A.'s progression, principles, and traditions.

• The archives committee held a workday back in February and were successful in emptying out our repository, resetting the shelves, setting up the workstations and getting the room organized and ready to be worked in.

- The committee had our first meeting on March 5, 2023 at 1:00pm at Intergroup and had 7 people in attendance.
- The committee elected a co-chair, secretary, and treasurer. We are still in need of an IT/Area IT liaison.
- The Committee voted to remove the Archivist position from the second page of the Area Archives Chair job description and add the Co-chair position. We believe that the archivist is an important role that has a different rotation cycle and a separate job description and should have their own position description page, separate from the chair. Job descriptions were written for the secretary, treasurer, and IT position. You can view these updated positions on our home page.
- The Archives committee unanimously approved to move the committee meeting to the 2nd Monday of each month at 7pm via Google Meet starting April 10, 2023. The committee no longer has face-to-face meetings at Intergroup. Our committee wanted to practice the principle of inclusivity and an online meeting will allow anyone in our area to participate in committee work.
- The Archives Workbook suggests other trusted servant positions that our committee can have, and they were approved at our meeting. We will need to develop job descriptions for each of these positions.
 - o Speaker Meeting Recorder responsible for obtaining speaker tapes for present and future events.
 - o Newsletter Editor design and produce an area 67 Archives Newsletter
 - o Researcher assists the archivist and chair in researching current archives material to ensure that it meets our criteria for notifying the committee of new materials that we may want to save. A researcher can also be assigned to gather group histories.
 - o Archives Service Coordinator carry archives displays to all service events and maintain their condition.
- The committee voted that we would read and discuss a small portion of the Archives Workbook at each meeting.
- The committee had a robust discussion about many aspects of archives, past, present, and future and were grateful to have Mike D. and Sara D. in attendance to keep us informed of past activities.
- The committee has no operating policies and guidelines, and I am currently working on these for committee review and vote.
- The committee asks that no one bring archives donations to Intergroup and drop them off. There is a formal process that needs to be followed for donations to archives. Please contact myself or Eddie R. our archivist.
- Until someone from Area IT is able and willing to come to Intergroup to help with our archaic computer systems, we are dead in the water concerning the digitizing of our repository documents. I reached out to "Brad" on March 30 and did not hear back as of Friday. In February I reached out to Sergey and Marshall but never received a response.

New Business Agenda Items for April

- Forming ad-hoc committee to work on written procedures for digitization and preservation of all archive's materials –
 will become part of Archives overall operating procedures and guidelines
- Do we want to add a Co-Archivist position
- Decide what documents, tapes, CDs, and VHS tapes are to be kept as a part of our historical collection.
- Open Positions Committee IT/Area IT Liaison, Speaker Meeting Recorder, Newsletter Editor, Researcher(s), Archives Service Coordinator
- Lastly, regarding donations per the GSO archives workbook, there is a required documentation process to donate any item to the Area Archives. Additionally, the committee has not set specific guidelines for what we are considering "of historical importance". If an individual, group, district, family member or friend wishes to donate materials to the Area Archives please contact me by email for more information.

Correction Facilities Committee (CFC) – Tony W.

The SETA Corrections Committee is charged with carrying the message of Alcoholics Anonymous to the suffering alcoholic behind the walls of our local, county, and state jails, as well as state and federal prisons; assisting with orientation processes to get people approved to take meetings into TDCJ facilities; distributing AA literature purchased with your BLUE CAN donations; answering letters from incarcerated inmates through the Correspondence Program; utilizing Bridging The Gap and the National CFC Pre-Release contact channels to assist in getting inmates to their first AA meeting upon release; and carrying the message through setting up information tables at workshops and conventions. We meet the third Wednesday of every month at 7:30 in the back room at Houston Intergroup. The Conference Committee meets an hour before that. Thank you Intergroup for the use of your room.

We are finishing up an Ad-Hoc whose duty is finding communication lapses and improvements between CFC, TFC, Intergroup, and anyone else using the Bridging the Gap program. Kendyl W did a fine job chairing this and we'll have the results and their findings in the next couple of meetings.

We are also looking to create a database that shows all of the facilities in our area, the ones we are taking meetings into, who is doing them and when. This is a painstaking endeavor but it is much needed.

World Services now has Conference-approved digital literature accessible on tablets and PCs with most of the popular reads from AA for incarcerated people. This is done at NO COST to inmates. We have contracts with many major vendors including ViaPath, Edovo/GTL, Securus-Jpay or Ingram 3 CoreSource — OverDrive, so our e-book and audiobook content can be accessed. Additional vendors will be added, and we hope to provide quarterly updates. Please contact corrections@aa.org to learn if there is tablet use in your area, which literature titles are being accessed most and for any additional information.

The Corrections Workbook is in its final stage of revision. An updated English version is expected March 2023. A section on sponsorship is included in the new workbook.

The proposed agenda item "Consider a request to include content in existing A.A. literature on sponsorship of persons in custody by outside members of the Fellowship" is being discussed by the Corrections Conference Committee. As this is a new growing area, the Conference Committee and the Trustees' Committee on Corrections has asked that we gather shared experience from those A.A. members providing online meetings for possible use in service material. Please email your shared experience by March 30, 2023, using the subject line "Shared Experience – Virtual meetings" to corrections@aa.org Local/Regional News.

- Since the beginning of January, I have worked with Catherine in her transition to the Area Treasurer. That took up much of January and the beginning of February.
- During the Area Convention we transferred the appropriate signers that were needed to be added to the correct bank accounts.
- We had no committee meeting at the convention. Then, changed the monthly Finance Committee meetings to the 3rd Wednesday of the month at 8:00p, except on the months that there is an Area Assembly then it is that Saturday afternoon during the committee breakouts.
- We updated the Finance Committee page and the meeting flyer.
- We sent out the 2024 budget worksheets to the budget holders. We had the budget meeting on Wednesday, March 8th at 7:30 pm and had 12 holders in attendance.

- We have a <u>proposed 2024 Area Budget</u>, there are copies in front of the podium and it was sent out thru SETA-Announce before the Assembly. There are 19 of us. Would the budget holders present in the assembly room now please stand. Contact them about budget questions before you contact me. I am the facilitator for the budget.
- Catherine has been very helpful with this process.
- We have already used \$12,000 of our prudent reserve only three months into the year.
- The 2024 Budget calls for \$33,000 in unrestricted funds in addition to the usual contributions and Prudent Reserve so that we have a balanced budget.
- To fully fund our Delegate to the 2023 General Service Conference would require \$8,200, but request from the General Service Office emphasizes if we can afford it.

Grapevine Statement of Purpose - This committee coordinates the work of individual AA members, groups, and districts to read, subscribe to, and utilize the Grapevine and Grapevine-produced materials. It also encourages individual AA members to contribute written, digital, and audio material to the Grapevine for publication.

Past Activities – The SETA Area 67 Grapevine committee set up a display at the SETA convention in January and secured multiple Grapevine subscriptions. Also, our alternate chairperson chaired one of the marathon meetings at the convention. We gave a Grapevine presentation at District 32 business meeting on February 5, 2023. Treatment Facilities Committee (TFC) – Christopher G.

Our Committee meetings are held on the 15th of each month on Zoom. We are currently looking into locations to provide a Hybrid Meeting format. We still have a few positions to fill, namely an Alternate TFC Chairperson and Accessibilities Chairperson. The TFC does have a Spanish Liaison, to better support our Spanish Speaking Districts and to communicate TFC initiatives!

The TFCommittee is focussing on (2) main goals this year:

To carry the message to "newcomer clients" by providing meetings inside Treatment Facilities. For this we need District support. The TFC will provide the resources necessary to train Group Members and AA Volunteers, with AA Guidelines,

Training presentations, GSO pamphlets & workbooks to use for Guidance, HOWEVER, we need District TF support to get the information to the group membership and Treatment Facilities.

Timely provide Bridging the Gap (BTG) Program information to the "newcomer clients" within our Treatment Facilities. For those of you not familiar with BTG: Bridging the Gap is a program by AA to assist the newcomer (namely, newly discharged TF clients, hospital patients, and newly released Prison Inmates), by bringing the newcomer to their first meetings and introducing the newcomer to the fellowship of AA. Keep in mind this is basic 12th-Step work, keeping with AA's singleness of purpose. We have been building the SETA Database of Temporary AA Volunteers for a couple of years now. For this initiative, we ALSO need District Member support... to bring BTG information to the newcomer and cooperating Facilities. The TFC will provide the resources of Training materials, AA Guidelines, and Training presentations. WE have produced (3) SETA BTG Pamphlets, in both English and Spanish, (1) to provide to the Facilities, (1) for their Clients and (1) for AA members volunteering to be "Bridges". All pamphlets have QR Codes to the national BTG Website. We also have bookmarks available for the TF Clients, with BTG contact information on one side and Houston Intergroup contact information on the other side. Both sides have respective QR Codes! We are currently drafting our own BTG-SETA workbook and it will appear in a TFC/BTG info-binder for each District. We hope to distribute at least (1) Info-binder per District beginning next month, regarding #1 and #2 above.

For the last year the TFC has fallen short on making "Bridges", using the National and SETA database of AA volunteers, meaning we are not getting the BTG information to the Clients within the Facilities. Our plan is to better communicate between SETA Committees and Districts, on a level we have not seen before, using the SETA and GSO resources available. We "are paving new ground here" to tailor an effective BTG program that meets the needs of SETA to reach the still-suffering alcoholic.

In closing, I wish to bring to your attention that SETA will be hosting the Bridging the Gap Workshop Weekend in September, across the boulevard at the Airport Sheraton. Here, we will exchange ideas and observe working models of how BTG works, from Areas located all over the US and Canada ... and have a few "jammin'" guest speakers. Please come by the TFC Table in the hallway and pick up the BTG Workshop Weekend Flyer to distribute among our AA membership.

I am very delighted to inform our Area of the changes being made within our small, yet still vital intergroup located in the Brazos Valley. Roger B. has volunteered to step up and become our new chair for Brazos Valley Intergroup. He is making major improvements to get our inner group organized and working more efficiently. He's printed out a P&P manual for all trustees and attendees, as well as creating more efficient 2023 financial budgets and records to help us follow up and keep better track of.

We also have a new bookkeeper Kimie W. who is in charge of setting up QuickBooks for our intergroup bookstore.

Treasurer's report- Roger B. reported BVIA operating results for the month ending February 28th, 2023.

Beginning cash balance=\$ 1646.05, donations \$1314.00, Bookstore sales = \$ 666.50, Bookstore gross income \$239.94. Total gross income = \$1553.94, expenses (overhead) = \$428.93. Net operating income = \$1125.01. Ending cash balance = \$2126.72.

Our volunteer hotline chair, Matt S., has reported we're averaging 3 calls a day with 65 volunteers on our hotline list, who take calls on a rotation system. He's implemented a hotline volunteer workshop being held on Saturday, April 22nd for anyone who is interested in learning more about how our hotline works and what the proper steps are in order to answer certain calls or go on 12 step calls. We're also planning to have assistance from either Houston or our Waco intergroups to help out with this workshop. All hotline volunteers, and or people that are interested in knowing more about how our hotline works are encouraged to attend.

We have a new website/IT chair, Phillip K., who has completely renewed our BVIA website page via WordPress, in addition to adding an SSL to the website and implementing the Meeting Guide app in connection with the website.

Bookstore operations—Our vice chairperson, Wayne S, has been in the process of remodeling our intergroup room. We are going to have new desks, and bookshelves built. As well as an archive section and area to purchase coins. We're making it to where we can actually shop, and it is run as an actual store now. We will also have a certain number of people who have access with the code to the room, and who are trained in knowing how to keep track of the inventory with the proper Ledger books or QuickBooks.
